## **C) PRIORITY CRITERIA FOR ADMISSION PROCEDURE UNDER SPECIAL DRIVE IN COMPLIANCE WITH KVS HQ LETTER NO. F.1100331/EDPOLA/1/2024-25/ACADEMIC DATE:31.07.2024**

After the registration against available vacancies, merit list will be drawn on the basis of following priority of service categories as per KVS Admission Guidelines 2024-25:

- 1) **CAT 1:** Children of transferable and non-transferable Central Government Employees and children of Ex- servicemen.
- 2) **CAT 2:** Children of transferable and non-transferable employees of Autonomous Bodies/Public Sector Undertaking/ Institute of Higher Learning of the Government of India.

## D) ELIGIBLE AGE LIMIT FOR ADMISSION

The minimum and maximum age limit for admission in Kendriya Vidyalayas in various classes is given below: **(Child born on 1<sup>st</sup> April should also be considered.)**

Class	Minimum / Maximum Age as on 31 <sup>st</sup> March of the Year in which admission is sought.
Class -I	6 years but less than 08 years of age.
II	7 years but less than 09 years of age
III	<b>8 years but less than 10 years of age.</b>
IV	8 years but less than 10 years of age.
V	9 years but less than 11 years of age.
VI	10 years but less than 12 years of age.
VII	11 years but less than 13 years of age.
VIII	12 years but less than 14 years of age.
IX	13 years but less than 15 years of age.
X	14 years but less than 16 years of age.
